## BOYS' STATE HISTORY

Kansas was one of the first to utilize this fine "learning-by-doing" government program. Since 1937 a total of over 30,000 Kansas high school juniors have participated in this program. This program is administered in Kansas by the Executive Committee of the Department of Kansas American Legion. For 26 years, Kansas Boys' State was headquartered in Wichita. In 1963, in order to provide larger and more suitable accommodations, the Department moved Boys' State to the University of Kansas Campus in Lawrence where it is housed in Templin, Lewis and Hashinger Halls.

Each boy is sponsored by an American Legion Post or by other patriotic, civic, fraternal or religious organization. Delegates become acquainted with the rights and privileges of citizenship. Upon arrival, each boy is assigned to a mythical political party and to a city and county. They become candidates for city, county and state offices, conduct their campaigns and elections according to the laws of the state. Legislative, administrative and judicial programs are developed. State legislative sessions, court trials, law and police schools, evening assemblies, band, chorus and other activities offer each boy the opportunity to participate.

Two fortunate Staters are chosen each year for participation in the Boys' Nation Program offered later in the summer by the American Legion and held in Washington, D.C. On this expense paid trip the Boys' Nation delegates meet with and are the guests of the Kansas delegation of U.S. Senators and Representatives.
